Report of the Supervisor of Elections
on the General Election 1976

Introduction

The duties and responsibilities of the Supervisor of Elections are set out in Section 30(1) of the Representation of the People Act, Cap 12 of the Laws of Barbados.

2. On Monday the 9th August, 1976, the Governor General by powers vested in him under Section 61 of the Constitution of Barbados, dissolved Parliament and issued writs to the Returning Officers for the twenty four (24) Constituencies set out in the First Schedule of the Representation of the People Act.

3. Notice of dissolution was published in the Official Gazette on the 9th August, 1976. Notices of election issued in accordance with Rule 3 of the House of Assembly Election Rules, were published in the Press and the Official Gazette of Wednesday the 11th August, 1976.

4. The writs issued in accordance with Section 36 of the Act, appointed Wednesday 18th August, 1976, as Nomination Day and Thursday the 2nd September, 1976 as Polling Day.

The Candidates

5. In addition to the two main parties contesting the election - The Barbados Labour Party and the Democratic Labour Party, a new Political Party - Viz: People's Political Alliance emerged to participate in the election. Sixty candidates contested the twenty four (24) seats.

6. Participation was as follows:-

- (1) Barbados Labour Party - 24 Candidates
- (2) Democratic Labour Party - 24 Candidates
- (3) People's Political Alliance - 8 Candidates
- (4) Independents - 4 Candidates

7. All eight (8) candidates of the People's Political Alliance as well as the four Independents lost their deposits, having failed to secure one sixth (1/6) of the total votes cast at the election in their respective constituencies.

Election Officers and their Responsibilities

8. In addition to the Supervisor of Elections and the Deputy Supervisor of Elections, a total of one thousand, three hundred and fifty nine (1,359) officers were engaged in the conduct of the elections. The following shows the distribution of these officers in the five (5) categories within the twenty four (24) Constituencies:-

25. The Supervisor of Elections personally selected the Official Marks. Each mark was subsequently sealed and addressed to the appropriate Presiding Officer with specific instructions not to open until Polling Day.

Storage of Election Documents

26. The election documents were delivered to the Supervisor of Elections by the Returning Officers on the night of the 2nd and the morning of the 3rd September, 1976. These documents were kept under constant police supervision until the 15th September when 45 bags were delivered to the Registrar in accordance with the provisions of Rule 56(2) of the Election Rules.

Candidates Election Expenses

27. Returns of election expenses were forwarded to the Supervisor of Elections by fifty six (56) of the sixty (60) candidates who contested the election, in accordance with the provisions of Section 52(1) of the Act. These returns have been filed with the Registrar in accordance with Section 60(1) of the Act. A summary of the expenses is at Part 111.

28. The following four (4) candidates/agents are guilty of an illegal practice in accordance with Section 55 of the Act:-

Conclusions

30. Between 1971 and 1976 Elections, the electoral roll increased by 19,052 or 16.5%, yet the attendance at the polls only increased by 5,444 or 5.8% over the 1971 Elections.

31. In the 1971 Elections 81.6% of the registered electorate voted compared with 74.1% at the 1976 Elections, a reduction of 7.5%.

32. There is a noticeable fluctuation in the percentage of persons attending the polling stations within Constituencies. In one Constituency attendance at a polling station was as low as 58.4% and reached 80.5% at another station just one (1) mile away. In another Constituency one area recorded 48.6% as its lowest attendance and 79.9% as the highest.

33. Examination of the 1971 statistics has shown that such a voting pattern did not exist. The reason for this lies in the fact that approximately 75% of the persons registered to vote at that election were photographed just three (3) months before the date of the election and consequently the list reflected a true position of the registered electorate.

34. The register used at the 1976 election was first prepared in 1971 and updated annually, since then with the addition of newly qualified electors, it has only reflected a small percentage of the population movement. There is no machinery to effect the removal of the names who had emigrated and therefore ceased to qualify.

35. Under the circumstances therefore, the register does not reflect a true position of the potential voters in the island. This is supported by the fact that a few hundred circulars were returned to the Supervisor of Elections, with the postal note 'Gone away' or 'Left address'.

36. In my opinion there is an urgent need for a house to house enquiry in order to remedy the situation.


