REPORT ON THE BARBADOS GENERAL ELECTION 2008

1. INTRODUCTION

1.1 On Thursday 20 December 2007, the Governor-General acting in accordance with Section 61 (2) of the Constitution of Barbados issued a Proclamation dissolving Parliament. Writs for an election in the thirty (30) constituencies were also issued on that date to the thirty (30) Returning Officers (Appendix A) appointed under Section 31(1) of the Representation of The People Act, Cap 12 (hereinafter referred to as the "Act").

1.2 The Writs issued in accordance with Section 36 of the Act appointed the following dates:-

31 December 2007	-	Nomination Day
15 January 2008	-	Polling Day
16 January 2008	-	Latest day for the return of Writs to the Governor-General.

1.3 In accordance with Section 18 (1) (a) of the Act, on Thursday 20 December 2007, the Governor-General issued a Proclamation declaring the period ending the 8th day of January 2008 as the Special Electoral Registration Period and on Friday 21 December 2007, by Order, appointed Wednesday 9 January 2008 as:

1. The Polling Day for Foreign Service Electors at Missions, in accordance with Rule 44 (1); and
2. The Special Polling Day for Election Officers, in accordance with Rule 30 (2A).

1.4 Supreme Court Suit No. 7 of 2008 – Douglas Trotman v Attorney General and The Electoral and Boundaries Commission

1.4.1 An action was brought by Douglas Trotman, an Attorney-at-Law, by way of Originating Summons filed on 4 January 2008, (1) challenging the date set for the holding of the general election and seeking, inter alia, a declaration that the 30 writs issued on 20 December 2007 by the Governor General under Section 62(1) of the Constitution acting on the advice of the Prime Minister, were invalid and void and of no effect and (2) claiming a declaration that the Special Electoral

Registration Period required to be declared under Section 18(1) of the Representation of the People Act Cap 12 of the Laws of Barbados was not complied with.

- 1.4.2 The Application was heard in open court on January 11, 2008 before Justice of Appeal Mr. Justice Frederick Waterman (acting President of the Court) and dismissed as being without merit.

2. **REVISED REGISTER OF ELECTORS – PRELIMINARY LIST**

- 2.1 The Electoral and Boundaries Commission (hereinafter referred to as the Commission) published the Preliminary List of Electors on 22 December 2007, in accordance with the provisions of Section 18 (1) (b) of the Act.

- 2.2 The Preliminary List which comprised two hundred and thirty four thousand, five hundred and fifty three (234 553) electors was made available to the two political parties, the Public Library, the Cabinet Office, the Electoral Department and the Registration/Revising Centres. On the 22 December 2007, a notice was placed in the press, which invited the public to inspect the Preliminary List, the notice provided the dates by which Claims and Objections were to be filed with the Registering Officers at the Revising Centres.

- 2.3 To facilitate inspection of the Preliminary List, by the general public, Registration Centres were established at the following locations:-

Emerald City Supermarket (Six Cross Roads)

Carlton Supermarket (Black Rock)

Courts (Sheraton)

Courts (Speightstown)

Courts (Bridgetown)

Super Centre (Warrens)

Super Centre (Oistins)

JB's Supermarket (Sargeants Village)

Big "B" Supermarket (Rendezvous)

- 2.4 The public was also informed via public notices in the newspapers that they should be registered on or before Monday 31 December 2007, in order to be eligible to vote at the election.

3. **ELECTION ADMINISTRATION**

- 3.1 The General Election of 15 January 2008 was conducted by the Commission in accordance with the provisions of the Representation of the People Act and Section 42 (1) of the Constitution of Barbados which provides as follows:-

“The election of members to the House of Assembly shall be conducted under the direction and supervision of the Commission”.

The members of the Commission are:-

- 3.2 Member of the Commission, Mr. Michael Yearwood, resigned with effect from 20 December 2007 and was replaced by Mr. Larry A C Smith with effect from 21 December 2007.
- 3.3 The Commission contracted the services of a Consultant, Mr. Hensley Robinson and in accordance with Section 30 (1) of the Act appointed Ms. Angela Goddard as Supervisor of Elections. The Governor General, in accordance with Section 30 (2) of the Act, appointed Mr. Ian Browne, the Deputy Supervisor of Elections.
- 3.4 In addition, two thousand, two hundred and forty five (2 245) officers were engaged in the conduct of the elections, in the following categories:-

4. **THE CANDIDATES**

4.1 Sixty eight (68) persons were duly nominated on the 31 December 2007 to contest the thirty (30) seats in the election as listed below:

Barbados Labour Party	-	30 Candidates

5. **POLLING STATIONS**

5.1 In establishing Polling Stations, the three hundred and thirteen (313) Polling Districts were divided into five hundred and thirty six (536) Polling Divisions which were housed in two hundred and sixty five (265) buildings. Of these, one hundred and twenty six (126) were government buildings and one hundred and thirty nine (139) privately owned properties. A complete list of the Polling Stations is at Appendix C.

6. **POLITICAL BROADCASTS**

6.1 Regulations 4 (a) & (b) of the General Elections (Allocation of Broadcasting Time) Regulations 1990 make provision for the allocation of broadcasting time during an election to any political party which satisfies the Commission

that no less than ten of its members are validly nominated candidates for the election.

- 6.2 The Barbados Labour Party and the Democratic Labour Party having complied with Regulation 4 and having submitted applications for the allocation of broadcasting time, were allocated broadcasting time as follows:-

Barbados Labour Party

- (1) 6 January 2008
- (2) 9 January 2008
- (3) 13 January 2008

Democratic Labour Party

- (1) 7 January 2008
- (2) 11 January 2008

7. **REORGANISATION OF POLLING DISTRICTS**

- 7.1 In accordance with Section 29 of the Representation of the People Act, the Commission had undertaken a revision of Polling Districts with registered electors in excess of one thousand, to reduce the number of electors (where practicable) and to address the distance some electors had to travel to polling stations. As a result, the number of Polling Districts was increased from two hundred and ninety (290) to three hundred and thirteen (313) with thirteen (13) constituencies affected.

- 7.2. In order to ensure that electors affected by the review were properly informed of the changes to the Polling Districts, Town Hall meetings were held as listed below:

8. PUBLIC RELATIONS

- 8.1 As part of the ongoing registration outreach programme, Electoral Information Centres were also established at the Speightstown, Bridgetown, Mall Internationale and Sheraton branches of Courts; the Warrens, Oistins and Southern Plaza branches of Super Centre; Big B and JB's Supermarkets; Carlton Supermarket and the Emerald City complex. The centres provided members of the Public the opportunity to check their electoral status and where necessary to have it regularized.
- 8.2 On Polling Day from 06:00 hours to 18:00 hours, Information Centres were in operation enabling persons to check the Register for information regarding their Polling District and/or Polling Station. These Centres operated from the following locations:
1. The Electoral Department (Bridgetown)
 2. The Alexandra School (St. Peter)
 3. The Princess Margaret Secondary School (St. Philip)
 4. The Glebe Polyclinic (St. George) and
 5. The Randal Phillips Polyclinic (Christ Church)
- 8.3 In addition, Clerks were deployed at buildings, which housed multiple Polling Stations for directing voters to their respective stations or to the Information Centres.
- 8.4 Circulars were sent to all electors informing of Polling District and Polling Station. Electors were also able to view their Polling Station (at which they

were registered to vote) on line via the Government Portal at <http://www.gov.bb>.

9. REGISTER FOR ELECTIONS

9.1 In accordance with Section 18 (3) of the Act, the Commission published a Register for Elections on Thursday 10 January 2008, which comprised two hundred and thirty five thousand, five hundred and ten (235 510) electors. It was made available to the political parties and other nominated candidates. It was also displayed for public inspection at the Public Library and the Electoral Department.

10. VOTING

10.1 VOTING BY ELECTION OFFICERS

10.1.1 Wednesday 9 January 2008 was designated Polling Day for the Election Officers. This was done to make it convenient for Election Officers to exercise their franchise before the 15 January 2008, Polling Day when they would be deployed at various Polling Stations, conducting the poll.

10.1.2 Special Presiding Officers were appointed by the Commission to supervise the voting, and polling was conducted between 7.00 a.m. and 5.00 p.m., at a station in each constituency.

10.1.3 One thousand three hundred and seventy eight (1 378) Election Officers registered to vote on Special Polling Day.

10.2. VOTING BY FOREIGN SERVICE ELECTORS

10.2.1 Wednesday 9 January 2008 was also designated as Polling Day for the Foreign Service Electors. The Electoral and Boundaries Commission in accordance with the provisions of Section 13 (1) of the Act, appointed the Heads of the Missions as Presiding Officers at the respective Missions.

10.2.2 Thirty one (31) Foreign Service electors registered to vote on Polling Day.

10.3 **VOTING BY OTHER ELECTORS**

10.3.1 Tuesday 15 January 2008 was designated as Polling Day for all other registered electors and polling was conducted between 6.00 a.m. and 6.00 p.m., at the designated stations in each constituency.

10.3.2 Two hundred and thirty four thousand one hundred and one (234 101) persons were registered to vote on Polling Day.

11. **COUNTING OF VOTES AND PUBLICATION OF RESULTS**

11.1 Transport Board buses with Police escorts were used to transport Presiding Officers with ballot boxes, other Election Officers and Polling Agents to the Counting Centres. Counting commenced at approximately 8.00 p.m.

11.2 During the Count the Returning Officer in each constituency made periodic reports to the media on the progress of the Count.

11.3 Two candidates Mr. Randall Rouse, the Democratic Labour Party candidate for St. Joseph, and Ms. V. Irene Sandiford-Garner, the Democratic Labour Party candidate for St. Andrew, requested and received a recount on the night of the election. Mr. Rommell Marshall, the Barbados Labour Party candidate for St. Michael West Central sought a recount through the Election Court.

12. **ELECTION CASE**

12.1 **Election Court Suit No. 148 of 2008 - Rommell Marshall v James Paul and The Electoral and Boundaries Commission**

12.1.1 An Election Petition was filed on February 1, 2008 on behalf of Petitioner Mr. Rommell Marshall, claiming a recount in respect of the final result of the election held on January 15, 2008 in the constituency of Saint Michael West Central.

12.1.2 The hearing of the Petition was before an Election Court comprised of Waterman CJ (ag.), Kentish J and Reifer J, on March 3 and 4, 2008. The Court

held that the Petition was deficient in that it did not disclose a prima facie case. The Petition was therefore dismissed.

13. **ELECTION EXPENSES**

13.1 In accordance with Section 52 (1) of the Act, all Candidates/Election Agents were required to file a Statement of Election Expenses with the Supervisor of Elections within seven weeks of the declaration of the results of the election.

13.2 Candidates/Election Agents are allowed to incur expenses to a maximum of \$10.00 in respect of each person registered as a voter in their respective constituencies. Appendix "D" shows the amount expended on behalf of each candidate.

13.3 The following three candidates have not submitted their Statement of Election Expenses:
