REPORT ON THE GENERAL ELECTION 2003

1. INTRODUCTION

- 1.1 The Commission having reviewed the number and boundaries of the constituencies into which Barbados is divided pursuant to Section 41D (1) of the Constitution submitted its Fourth Report to the Prime Minister in March 2002 and recommended, *inter alia*, that Barbados be divided into thirty (30) constituencies by the creation of two (2) new constituencies to be named St James Central and St Philip West. As a consequence, alterations were made to the boundaries of certain constituencies.
- 1.2 On Friday 25 April 2003, the Governor-General acting in accordance with Section 61 (2) of the Constitution of Barbados issued a Proclamation dissolving Parliament. Writs for an election in the thirty (30) constituencies were also issued on that date to the thirty (30) Returning Officers appointed under Section 31(1) of the Representation of The People Act, Cap. 12 (hereinafter referred to as the "Act").
- 1.3 The Writs issued in accordance with Section 36 of the Act appointed the following dates:-

6 May 2003	-	Nomination Day
21 May 2003	-	Polling Day
22 May 2003	-	Latest day for the return of Writs to the Governor-General.

- 1.4 On Monday 28 April 2003, the Governor-General acting in accordance with Rule 44 (1) appointed Thursday 15 May 2003 as the Polling Day for Foreign Service Electors at Missions. The Governor-General acting in accordance with Rule 30 (2A) also appointed Thursday 15 May 2003, as the date for Special Polling Day for Election Officers voting at the election.

2. ELECTION ADMINISTRATION

2.1 Section 42 (1) of the Constitution of Barbados provides as follows:-

"The election of members to the House of Assembly shall be conducted under the direction and supervision of the Commission".

2.2 The General Election of 21 May 2003 was conducted by the Electoral and Boundaries Commission (hereinafter referred to as the "Commission") in accordance with the provisions of the Constitution and the Representation of the People Act. The members of the Commission were:-

2.3 In accordance with Section 30 (1) of the Act, Mr. Hensley Robinson was appointed the Supervisor of Elections. The Governor-General, in accordance with Section 30 (2) of the Act, appointed Mr. Donville Johnson, the Deputy Supervisor of Elections.

3. THE CANDIDATES

3.1 Sixty-two (62) persons were duly nominated on the 6 May 2003 to contest the thirty (30) seats in the election. Thirty candidates each representing the Barbados Labour Party and the Democratic Labour Party were nominated to contest the election. The remaining two candidates were Independents.

4. ELECTION OFFICERS

4.1 In addition to the Supervisor of Elections and the Deputy Supervisor of Elections, two thousand, two hundred and six (2 206) officers were engaged in the conduct of the elections. These comprised the following categories:-

5. POLLING STATIONS

- 5.1 Two hundred and ninety (290) polling stations were established for this election. These were divided into five hundred and twenty-three (523) polling divisions which were housed in two hundred and forty-eight (248) buildings. Of these, one hundred and twenty-six (126) were privately owned properties. A complete list setting out the locations of the stations is at Appendix C.

6. POLITICAL BROADCASTS

- 6.1 Regulations 4 (a) & (b) of the General Elections (Allocation of Broadcasting Time) Regulations, 1990 make provision for the allocation of broadcasting time during an election to any political party which satisfies the Commission that no less than ten of its members are validly nominated candidates for the election.
- 6.2 The Barbados Labour Party and the Democratic Labour Party complied with Regulation 4 and submitted applications for the allocation of broadcasting time. The Commission allocated broadcasting time as follows:-

Barbados Labour Party

- (1) 11 May 2003
- (2) 15 May 2003
- (3) 18 May 2003

Democratic Labour Party

- (1) 13 May 2003
- (2) 17 May 2003

7. PUBLIC RELATIONS

- 7.1 The Supervisor of Elections and the Deputy Supervisor of Elections conducted interviews with the Media to inform the electorate on the exercising of its franchise. This was augmented by the presentation of programmes on the Government Information Service.
- 7.2 The Supervisor of Elections, Mr. Hensley Robinson and the Chairman of the Commission, Mr. Philip Serrao were interviewed on separate occasions by Mr. Dennis Johnson of the Caribbean Broadcasting Corporation as he hosted the "Morning Barbados" programme on CBC Television.
- 7.3 Prior to the announcement of the election date, Electoral Information Centres were established at Courts, Speightstown; Carlton Supermarket, Black Rock; Super Centre, Oistins; Julie N', Haggatt Hall and the Emerald City complex at Six Roads, St Philip. Those centres were opened to give members of the Public the opportunity to check their electoral status, the location of their polling stations and where necessary have them regularized.
- 7.4 The Electoral and Boundaries Commission held two public discussions (Town Hall meetings) in each constituency to enlighten electors in the new constituencies and the adjoining constituencies of the changes which had been made and how those changes would affect them. The meetings were held on:-

22 January 2003	-	Bagatelle Pavilion, St Thomas
23 January 2003	-	Princess Margaret Secondary School
11 February 2003	-	St James Secondary School
13 February 2003	-	St Bartholomew's Church Hall

- 7.5 The meetings at Bagatelle Pavilion and the Princess Margaret School were well attended.
- 7.6 Meetings were held with media personnel to clarify their roles on polling day and the arrangements for coverage of the proceedings during the count on election night.
- 7.7 On Polling Day extra Poll Clerks assisted at buildings, which housed multiple stations and divisions. They directed voters to their respective stations or to Voter Information Centres.
- 7.8 From 06:00 hours to 18:00 hours on Polling Day, Information Centres were established at Courts, Speightstown; Carlton Supermarket, Black Rock; Super Centre Supermarket, Oistins; Sheraton Centre and the Emerald City Supermarket, Six Cross Roads, St Philip.

8. REGISTER FOR ELECTIONS

- 8.1 In accordance with the provisions of Section 18 (1) (b) of the Act, the Commission published the Preliminary List of Electors on 28 April 2003.
- 8.2 The Preliminary List comprised two hundred and nineteen thousand, six hundred and eighty-five (219 685) electors. This was made available to the two political parties, the Public Library, the Cabinet Office, the Electoral Department and the Registration/Revising Centres. On the 28 April 2003, notices were placed in the Press inviting the public to inspect the Preliminary List and the dates by which Claims and Objections were to be filed with the Registering Officers.
- 8.3 In order to provide access to the public to enable them to inspect the Preliminary List, the following additional Registration Centres were established:-

Emerald City Supermarket (Six Cross Roads)

Carlton Supermarket (Carlton, Black Rock)

Courts (Sheraton)

Courts (Speightstown)

Courts (Bridgetown)

Super Centre (Warrens)

Super Centre (Oistins)

JB's Supermarket (Sargeants Village)

Big "B" Supermarket (Rendezvous)

- 8.4 The public was also informed via public notices in the newspapers that they had to be registered on or before Monday 5 May 2003, in order to be eligible to vote at the election.
- 8.5 In accordance with Section 18 (3) of the Act, the Commission published a Register for Elections on Friday 16 May 2003, which comprised two hundred and twenty thousand and ninety-three (220 093) persons. It was made available to the political parties and for inspection at the Public Library and the Electoral Department.

9. VOTING BY ELECTION OFFICERS

- 9.1 Thursday 15 May 2003 was designated as Polling Day for the Election Officers. This was done in an effort to ensure that Election Officers had the opportunity to exercise their franchise before 21 May 2003, the designated Polling Day for the rest of the country.
- 9.2 Special Presiding Officers were appointed by the Commission to supervise the voting, and polling was conducted between 7.00 a.m. and 5.00 p.m., at a centre in each constituency.

10. **COUNTING OF VOTES AND PUBLICATION OF RESULTS**

- 10.1 Transport Board buses with Police escorts were used to transport Presiding Officers with ballot boxes, other Election Officers and Polling Agents to the Counting Centres. Counting commenced at approximately 8.00 p.m.
- 10.2 During the Count the Returning Officer in each constituency made periodic reports to the media on the progress of the Count.
- 10.3 No candidate considered it necessary to request a recount.

11. **ELECTION EXPENSES**

- 11.1 In accordance with Section 52 (1) of the Act, all Candidates/Election Agents were required to file a Statement of Election Expenses with the Supervisor of Elections within seven weeks of the declaration of the results of the election.
- 11.2 Candidates/Election Agents are allowed to incur expenses to a maximum of \$10.00 in respect of each person registered as a voter in their respective constituencies. Appendix "D" shows the amount expended on behalf of each candidate.
- 11.3 Two candidates have not submitted their returns and this is receiving the attention of the Electoral and Boundaries Commission.
